



This past year has been very exciting, not to mention busy, as the Centre of Korean Studies has hosted close to thirty seminars, workshops and other Korea-related events at SOAS. They could not have taken place without the "Overseas Leading University Program for Korean Studies" grant received from the Academy of Korean Studies (AKS). The Centre is also grateful to the Embassy of the Republic of Korea and the Korean Cultural Centre in London for their continuous support.

CKS prides itself on its extensive program of Korea-related events.

It is difficult to single out highlights from 2015/16, but noteworthy are the specialised workshops and conferences organised by CKS members that brought together leading international scholars. They included the workshop organised by Owen Miller on Writing North Korean Social History, and Hyunseon Lee's twoday conference on Film and History: the Korean Example. Another memorable event was the book launch of Professor Martina Deuchler's new monograph Under the Ancestors' Eyes - Kinship, Status, and Locality in Premodern Korea. The Centre was also proud to be involved in the three-day Joint East Asian Studies Conference which was held in early September.



Academic exchange is central to CKS activities and over the past year the Centre has hosted more than ten visiting scholars, most of them from South Korea, and their presence at SOAS has greatly enriched our research environment

The Centre also plays an important role in supporting post-graduate students working on Korea-related topics. The Overseas Leading University Programmes grant provided by the AKS enabled the Centre to give four scholarships to SOAS MA and PhD students. In addition, one student received the annual Sochon Foundation Scholarship.

I would like to thank my colleague, Dr. Grace Koh for chairing the Centre in term 1 while I was on sabbatical. I would also like to thank Mrs Jane Savory and Ms Nenna Chuku in the Centres and Programmes Office at SOAS for their assistance and hard work throughout this past year. For the last year the Centres and Programmes Office has been assisted in organising and promoting the CKS Seminars by final year PhD student Simon Barnes-Sadler. Having now submitted his thesis for examination, he will be continuing both to work with the Centres and Programmes Office and to investigate linguistic variation in diaspora varieties of Korean as well as quantitative approaches to linguistic variation in Korean as a Research Fellow at the CKS.





During the academic year of 2015/16, Dr Horlyck continued her research and teaching activities. Much of her research time, including her sabbatical in term 1, was devoted to the completion of her monograph on modern and contemporary Korean art. She also gave several talks on Korean material culture at institutions in the UK and elsewhere. In addition she continued to serve as secretary of the British Association of Korean Studies (BAKS) and on the grants committee of the British Korean Society (BKS).

Successful viva of Sangpil Jin

We would like to congratulate Sangpil Jin for successfully defending his thesis: Korean Neutralisation Efforts (1882-1907): Retracing the Struggle for Survival and Imperial Intriques.

The study employs under-utilised multi-lingual archival sources from the three continents. It sought to approach Korean neutralisation, an under-researched topic in the academia, with a rigorous analysis covering relevant factors over a multi-year period.

As Sangpil's supervisor, Dr Anders Karlsson, offered him congratulations on an excellent thesis and well defended viva.

These included: in October 2015 a workshop at the Max Planck Institute for Social Anthropology in Halle, Germany on the topic of 'Beyond the Eurocentrism Debate' where he presented on Korean historiography and the problem of Eurocentrism. In January 2016 he participated in a conference at EHESS in Paris on the subject of 'Pre-Modern Korean Studies in Europe' where he presented on the topic of 'The end of the Choson Dynasty from an economic history perspective'.

In April Owen was invited to speak at Oslo University on the topic of his recent research on the formation of the industrial working class in North Korea. He also presented the same paper at the Comparative Histories of Asia seminar at the Institute of Historical Research, University of London.

In term 2 this year Owen was on research leave, which enabled him to finish writing a chapter on Korean history for an edited volume entitled Historical Sociology and World History.

He also gave a lecture on the Korean language and script to British students at a K-Pop Academy organised by Korean Cultural Centre in London on 12th March. He was also invited as a keynote speaker to the 26th International Conference on Korean Language Education held in August at Dongguk University in Seoul.

WELCOME TO SOAS LIBRARY

SOAS Library is one of the world's most important academic libraries for the study of Africa, Asia and the Middle East, which attracts scholars from all over the world to conduct research. The Library houses over 1.2 million volumes at the SOAS campus at Russell Square in central London, together with significant archival holdings, special collections and a growing network of electronic resources.








Librarian's Report

The Library holds some 80,000 monographs for Korean studies including publications from North Korea and official reports produced by the Governor-General of Korea. There are some 400 Korean language periodicals, some 300 western language periodicals, and over 500 audio-visual materials for teaching and research in Korean studies; the online catalogue is available at: library.soas.ac.uk



The Library subscribes to major research databases including Korean language databases with financial support (US\$5,000) from the Korea Foundation for the seventh consecutive year. SOAS academics and students have access to full-text journal databases (such as DBPia and KISS), reference databases (such as KRPia) and a newspaper database (NK Pro and Chosun Ilbo Archive). External members are welcome to use these databases in the Library.

A one-year retro-conversion Korean cataloguing project was completed in December 2015, which was supported by a grant from the Korea Foundation's Korean Studies Library Enhancement Project. Catalogues of nearly 14,000 books were newly entered or enhanced with Korean script.

The Korea Collection has sent some books to off-site storage this year to ease a space problem. All books were catalogued online before transfer, and are retrievable through an online request form. Meanwhile, additional shelving space for the Collection in the Library was agreed, so book moves will be the first project in the coming academic year.

As in previous years, the Library has received resources for Korean studies from various institutions in Korea including



the Academy of Korean Studies, Dongguk University, Institute for the Translation of Korean Classics, Korea Foundation, Korean Film Archive, Korean Publishers Association, Kyujanggak Institute for Korean Studies, Literature Translation Institute of Korea, National Assembly Library of Korea, National Institute of Korean History, National Library of Korea, National Museum of Korea, Northeast Asian History Foundation, and Suwon Museum.






SamulNori. Korean Percussion for a Contemporary World HOWARD, Keith Ashgate, 2015

SamulNori is a percussion quartet which has given rise to a genre, of the same name, that is arguably Korea's most successful 'traditional' music of recent times. Today, there are dozens of amateur and professional samulnori groups. There is a canon of samulnori pieces, closely associated with the first founding quartet but played by all, and many creative evolutions on the basic themes, made by the rapidly growing number of virtuosic percussionists. And the genre is the focus of an abundance of workshops, festivals and contests. Samulnori is taught in primary and middle schools; it is part of Korea's national education curriculum. It is a familiar part of Korean performance culture, at home and abroad, in concerts but also in films and theatre productions. SamulNori uses four instruments: kkwaenggwari and ching small and large gongs, and changgo and puk drums. These are the instruments of local percussion bands and itinerant troupes that trace back many centuries, but samulnori is a recent development of these older traditions: it was first performed in February 1978. This volume explores this vibrant percussion genre, charting its origins and development, the formation of the canon of pieces, teaching and learning strategies, new evolutions and current questions relating to maintaining, developing, and sustaining samulnori in the future.



Korean Musical Instruments: A Practical Guide (Second edition) HOWARD, Keith Minsokwon, 2015

A guide to Korean instruments, focussing on seven key string, percussion and wind instruments: kayagum, komun'go, haegum, changgo, p'iri, taegum, tanso. Each instrument is discussed historically and in its regional context. Different versions of each, and related instruments are described. Playing methods and techniques are given, coupled to photographs and other illustrations, then notations are introduced, building to sets of exercises and pieces given in both Korean mensural and staff notations. Two additional chapters give an historical overview, a broad consideration of different notation systems used in Korea, and an organological account of all traditional Korean instruments. Rewritten, expanded, newly illustrated edition of book originally published in 1988.



Biography

SOAS University of London has paid tribute to its former Director, Professor Paul Weblev. CBE, who has passed away aged 62. Paul joined SOAS in 2006 and served as its eighth Director and Principal until 2015.

Current SOAS Director, Baroness Valerie Amos said: "Paul made a tremendous contribution to both SOAS and the wider academic community - as an inspired leader of our renowned specialist institution, as an eminent economic psychologist, as a member and chair of many influential bodies in higher education and as an unstinting champion of specialised research and of freedom of speech. His work was fittingly recognised in the award of a CBE in the 2015 New Year's Honours list."

"As we approach our centenary in 2016-17, SOAS can be proud to have had Paul as its champion and leader for the last decade. He leaves a great legacy. Paul's warmth, generosity and loyalty was felt by all. The whole SOAS community of staff and students, alumni and friends and supporters are greatly saddened by his loss and our thoughts are with Julie and his family."

An economic psychologist by training, Paul graduated from the LSE with both a first class honours degree and a doctorate on children's perception of deception. He joined SOAS after 26 years of distinguished research, teaching and leadership at the University of Exeter, where he served as Deputy Vice Chancellor 2003-2006.

In his first three years as SOAS Director, Paul developed strong personal relationships with universities and funders in South Korea, Japan and China, including Taiwan. Under his leadership the School significantly strengthened its academic position. The study of Politics, Economics, Law, Business and Management, and Development Studies grew apace in line with the burgeoning interest in these fields among undergraduate and postgraduate students from all over the world. The growth in the number of students at SOAS was phenomenal, from about 2,000 to nearly 5,000 during his period of office.

Paul was also a fierce advocate of the importance of free and informed debate on some of the most contentious and hotly disputed issues in a number of areas of the world.

His inspiring vision for the School also led to the creation of two new institutes - the China Institute and the South Asia Institute, bringing together academics, public servants, media and the business sectors to debate key issues of global concern, thereby enhancing the experience of our students.

AKS KOREAN STUDIES GRANT 한국학중앙연구원 장학금 소개

Project Implementation for 2015-16 Period Project Goals & Original Project Plan

In 2011, SOAS was selected as beneficiary of the Overseas Leading University of Korean Studies after having successfully completed the AKS Korean Studies Institution Grant Programme for five years from 2006 to 2011. The new project, subsequently renamed as the Core University Program for Korean Studies, has been implemented for another five years from 2011 to 2016. The grant has allowed the Centre to significantly expand its manpower and infrastructure, its research programme, its worldwide profile and its event calendar. Specifically, the plan for the second grant period covers the following areas:

- Development of research manpower
- Expanding Centre of Korean Studies Seminars
- Organisation of Conferences and Workshops
- Development of curriculum materials and publication of research outputs
- Scholarships for Postgraduate Students
- Publication of Seminar and Conference/Workshop Papers

The details of project implementation so far are as follows:

1) Development of research manpower

The research manpower in the SOAS Centre of Korean Studies has been augmented by the creation of 1.8 fulltime research fellows. The full-time (1.0) position was awarded to Mr Sangpil Jin, in September 2013. Mr Jin's duties included organising seminars, assisting workshops, and carrying out other administrative works associated with the Centre. The second position (0.8) was awarded to Dr Youkyung Ju in May 2014, and she has conducted research on Korean linguistics. Subsequently, she has been appointed as a Senior Lector in Korean and started teaching Korean at the department of Japan and Korea. In September 2015, Mr Simon Barnes-Sadler replaced Mr Sangpil Jin as a new research fellow.

2) Expanding Centre of Korean Studies Seminars

In the 2015-2016 academic year, a total of eighteen lecturers were invited from leading academic institutions from Europe, the USA, Korea, and Japan. The institutions include Gyeongsang National University, Toronto, Ruhr-Uniersitat, Claremont McKenna Colleage and various UK Universities including University of Central Lancashire and London School of Economics.

3) Organization of Conferences and Workshops


During the last year, the Centre was able to hold a workshop on North Korean social history. The workshop was held on 11 September 2016 and brought together scholars from North America and Europe working on this developing field. The Film and History: The Korean Example conference took place at SOAS and The London Korean Cultural Centre UK on 5-6 November 2016 and focused on the representations of history on film and the links between historical research and filmic presentations of history.

4) Development of curriculum materials and research publications During the last academic year, centre teachers have been engaged on several different projects including:

- 1. the development of up-to-date, authoritative language textbooks to meet the needs of teachers of Korean language and literature in Western universities:
- two book projects on Korean Music: SamulNori: Korean Percussion for a Contemporary World, and Korean Musical Instruments: A Practical Guide, both authored by Professor Keith Howard:
- 3. an edited volume on state-of-the-art overviews of linguistics research on the Korean language, which was published as 'The Handbook of Korean Linguistics' by Wiley-Blackwell in June 2015 by Professor Yeon and Dr Brown.

5) Support for Postgraduate Students

To facilitate potential Korean studies postgraduate students, over the past eight years we have set up the SOAS-AKS Postgraduate Bursary. The bursary, valued up to £6,000, is used to cover the cost of tuition fees. Living costs are not available as part of the award and the bursary is not renewable. Candidates are assessed on academic merit. Programs eligible for the bursary include MA Korean Studies, MA Korean Literature, MA History of Art (Korean pathway) and other Korea-related postgraduate programmes. The number of recipients last year includes three MA students and two PhD students.



6) Publication of Seminar and Conference/Workshop Papers Over the past four years, the CKS has held 58 seminars and numerous papers were presented at various workshops and conferences. To provide a lasting record of the ground-breaking and thoughtprovoking research that has been presented, we have collected copies of these papers from many of the speakers. From 2011, the papers were published online in the SOAS-AKS Working Papers in Korean Studies series: (www.soas.ac.uk/koreanstudies/overseasleading-university-programmes/soas-aks-working-papers-inkorean-studies-ii/). We plan to select the best papers from the online working papers to be published in a regular edited book.

Eojin KIM

Eojin Kim is a research professor in the Department of Political Economy at Gyeongsang National University in South Korea. Dr Kim's Ph.D. focused on the Marxist theory of contemporary imperialism in East Asia. The title of her doctoral thesis was "A study on the nature of South Korean capitalism with the help of the theory of imperialism". She gives lectures on the economic history of South Korea from a Marxist perspective, The Capital, and Imperialism at Gyeongsang National University.

Sangmi BAE

Sangmi Bae is a visiting scholar in the Centre of Korean Studies at SOAS, University of London and a Ph.D. candidate in the Department of Korean Language and Literature at Korea University. She is a member of the editorial board of *A Journal of Feminist Theories and Practices*.

Professor Keith HOWARD

Professor Keith Howard is Professor of Music and member of the Centre for Korean Studies at SOAS, University of London. He has written or edited 19 books, including Music as Intangible Cultural Heritage: Policy, Ideology and Practice in the Preservation of East Asian Traditions (2012), Singing the Kyrgyz Manas (with Saparbek Kasmambetov, 2011), Korean Kayagum Sanjo: A Traditional Instrumental Genre (with Chaesuk Lee and Nicholas Casswell; 2008), Zimbabwean Mbira Music on an International Stage (with Chartwell Dutiro; 2007), Creating Korean Music: Composition and the Discourse of National Identity (2006), Preserving Korean Music: Intangible Cultural Properties as Icons of Identity (2006), and Korean Pop Music: Riding the Wave (2006). Over the last 30 years, he has also published more than 150 academic articles and 150 book/ music reviews, as well as writing for many newspapers and journals including The Times, The Telegraph, Times Education Supplement, Korea Herald, Korea Times, Reader's Digest, Koreana, Morning Calm and more. He has been a regular broadcaster on Korean affairs for BBC, ITV, Sky, NBC and others. He is editorial chair for the SOAS Musicology Series (Ashgate) and sits on a number of other editorial and advisory boards. He founded and managed the SOASIS CD and DVD series as well as OpenAir Radio.

Jung-Ah WOO

Jung-Ah Woo earned her Ph.D. in art history from the University of California at Los Angeles, and her MA and BA from Seoul National University. Her research area is postwar art of East Asia and the United States with particular interests in collective memory, historical trauma, and identity politics.

Graeme GILLOCH

Dr Graeme Gilloch is Reader in the Department of Sociology at Lancaster University. The principal focus of his academic work is the sociology of culture and cultural theory, and more specifically, the writings of particular scholars associated with the Frankfurt Institut fuer Sozialforschung (the Frankfurt School): the Critical Theorists Walter Benjamin, Siegfried Kracauer and, more recently, Leo Lowenthal. He has published extensively on Benjamin including two monographs Myth and Metropolis (1996) and Walter Benjamin: Critical Constellations (2002), and more recently has published a number of pieces on Kracauer. His recently published book, Siegfried Kracauer: Our Companion in Misfortune (2015) constitutes the first major analysis and assessment of his work as a whole in English. With fieldwork funding from the Korea Foundation, he is presently collaborating on a 'rhythmanalysis' of South Korea's second city, the port of Busan, drawing on urban and spatial motifs from the work of Henri Lefebvre, Marc Auge and Krakauer. As part of his work on film, he gave the keynote address at the 2014 Busan International Film Festival.

Hazel SMITH

Professor Hazel Smith is the Director of the International Institute of Korean Studies UCLAN (IKSU). Professor Smith's publications include North Korea: Markets and Military Rule (2015), 'Reframing North Korean Human Rights' (with Christine Hong), Critical Asian Studies, December 2013/ March 2014, Reconstituting Korean Security (2007); Hungry for Peace: International Security, Humanitarian Assistance and Social Change in the DPRK (2005) and North Korea in the New World Order (1996). Professor Smith received her PhD in International Relations from the London School of Economics in 1993, has held prestigious competitive fellowships including at the Woodrow Wilson International Center for Scholars (2012/2013), the East-West Center, Honolulu (2008 and 2015), Kyushu University (2010), the United States Institute of Peace (2001/2002), and was a Fulbright scholar at Stanford University (1994/1995). Professor Smith regularly broadcasts for the global media on North Korea, where she lived and worked for international humanitarian organisations for two years and from where she earned a (still valid!) North Korean driving licence.

Janet POOLE

Janet Poole's research focuses on the relationship between aesthetics and formations of colonialism and postcolonial national division, explored through literature, art and material culture, and on literary translation and theories of translation. Her cultural history of writing in the late colonial and Pacific War era recently appeared as When the Future Disappears: The Modernist Imagination of Late Colonial Korea (Columbia University Press, 2014) and was awarded the Modernist Studies Association Book Prize for 2015. She has translated the works of many writers from colonial Korea, including a collection of anecdotal essays published during the Pacific War by Yi T'aejun, Eastern Sentiments (Columbia University Press, 2013). She is currently Associate Professor at the University of Toronto, where she teaches Korean literature and cultural history.

Jimmyn PARC

Jimmyn Parc (Ph.D) is a visiting lecturer at Sciences Po Paris and an associated researcher at the EU Center, Graduate School of International Studies, Seoul National University. He also serves as the director of Groupe d'Economie Mondiale Junior (GEM Junior) at Sciences Po and he is a non-residential researcher at the European Centre for International Political Economy (ECIPE, Brussels).

His current main research topics focus on cultural industries and strategies of different business systems, accompanied with business economic and historic perspectives. He has published numerous academic articles and conducted various research projects related to competitiveness of organizations, industries, and countries.

From 2008 to 2010, he worked for the Institute for Industrial Policy Studies (IPS) in Seoul, Korea, as a researcher for conducting research on national, corporate, and other organizational competitiveness. He participated in consulting projects for private companies (Samsung Electronics Co.), national organizations (the Korea Industrial Complex Corp., Korean Trade and Investment Promotion Agency, Ministry of Justice, Ministry of Knowledge and Economy, and the Prime Minister's Office of the Republic of Korea), and foreign governments (Azerbaijan and Dubai). In 2010, he was also engaged in a research project on foreign direct investment with the Vale Columbia Center (VCC) on Sustainable International.

Miriam LÖWENSTEINOVÁ

Miriam Löwensteinová, Ph.D. (Associate Professor of Korean Studies, Charles University in Prague). Her research concerns mostly pre-modern Korean literature, especially chronicles, historical prose, diaries, and p´aesŏl literature. She has translated both classical and modern literature, prose, and poetry (the most recent translations being the *Samguk yusa*, Ko Ŭn's *Maninbo*, Yi Mun-yŏl's *Siin*, Yi Sǔng-u's *Saengùi i myŏn*). She lectures on Korean literature, history, and cultural tradition, and has written books and articles on various themes in Korean literature (including essays on classical literature, historical stories from the Samguk and T'ongil Silla period and a volume on the history of modern Korean literature.

Patrick MESSERLIN

Patrick Messerlin is Professor Emeritus of economics at Sciences Po, Paris, and serves as Chairman of the Steering Committee of the European Centre for International Political Economy (ECIPE, Brussels). He was also a Visiting Professor at the Graduate School of International Studies, Seoul National University (2013).

His current research deals with EU-East Asia economic and trade relations, cultural industries, and regulatory reforms in the EU. He is the author of many articles, reports, and books, in particular *Measuring the Costs of Protection in Europe: European Commercial Policy in the 2000s* (Peterson Institute for International Economics 2001) and *Europe after the No Votes* (Institute of Economic Affairs 2006)

He was a special advisor to Mike Moore, WTO Director General (2001-2002). He served as co-chair, with Ernesto Zedillo (former President of Mexico and Director of the Yale Center for the Study of Globalization) of the United Nations Millennium Development Goals Task Force on Trade for Development (2003-2005), and of the joint World Bank & UK Department for International Development Task Force on Global Finance and Trade Architecture (2008-2011). He was a member of the Global Agenda Trade Council of the World Economic Forum (2009-2012).

NOH Suntag

Noh Suntag (b. 1971, Seoul) is the winner of the 2014 Korea Artist Prize, equivalent to the Turner Prize in the UK, awarded by the National Museum of Modern and Contemporary Art, Korea and the SBS Foundation. Recent solo exhibitions include 'Really Good, Murder', Gallery Sugata, Kyoto, Japan (2015); 'Forgetting Machines', Hakgojae Gallery, Seoul, Korea (2012), 'Estat d'excepcio', La Virreina, Barcelona (2009); 'Appropriating Reality / the Room', Total Museum of Contemporary Art, Seoul, Korea (2009); and 'State of Emergency', Württembergischer Kunstverein, Stuttgart, Germany (2008). A forthcoming solo exhibition will take place at Art Sonje Center, Seoul Korea in May 2016.

Nemo KIM

Nemo Kim is a Seoul-based journalist who has reported on Korea for KBS, NHK World, CNN.com, Nikkei Asian Review and Monocle. Her writing on Asian cinema has appeared in Variety and Sight and Sound. She teaches Korean Studies at Hankuk Univ. of Foreign Studies in Seoul. Prior to that, she taught in the Korean Department at SOAS, Univ. of London. She has a BA in English and an MA in Comparative Literature (Univ. of London) and she has also studied International Relations at graduate level at Cambridge.

Hyun Bang SHIN

Hyun Bang Shin is Associate Professor of Geography and Urban Studies in the Department of Geography and Environment, London School of Economics and Political Science. His research centres on the critical analysis of the political economic dynamics of speculative urbanisation, the politics of redevelopment and displacement, housing, state entrepreneurialism, the right to the city, and mega-events as urban spectacles, with particular attention to Asian cities. His recent books include a co-edited volume Global Gentrifications: Uneven Development and Displacement (Policy Press, 2015) and a co-authored monograph Planetary Gentrification (Polity Press, 2016). The publication of these books emanated from a series of workshops Towards an Emerging Geography of Gentrification in the Global South in 2012, funded by the Urban Studies Foundation. His other on-going book projects include a monograph Making China Urban (Routledge, 2017). and a co-edited volume Contesting Urban Space in East Asia (Palgrave Macmillan, 2016). Hyun serves the journal CITY as a senior editor, is a board member (trustee) of the Urban Studies Foundation, and sits on the board of several journals including Antipode, City, Culture and Society and China City Planning Review. He is also an organising member of the London-based interdisciplinary seminar series the Urban Salon.

Young-mee Yu CHO

Young-mee Yu Cho is Associate Professor of East Asian Languages and Cultures at Rutgers, the State University of New Jersey in the U. S. and her current research interests include phonology, morphology and Korean language pedagogy. Her recent publications include *Parameters of Consonantal Assimilation* (1999), *Integrated Korean: Beginning & Intermediate* (2000-2012) (co-authored textbook series), *Standards for Korean Language Learning* (2012) (co-chair, ACTFL), *College Korean Curriculum Inspired by National Korean Standards* (2015) (as guest editor, Korean Language in America), "Syllable-Based Phonological Processes" in *Handbook of Korean Linguistics* (2015), "Beyond 'Power and Solidarity': Indexing Intimacy in Korean and Japanese Terms of Address." (2013) (co-authored) in *Korean Linguistics*, and "Laryngeal Contrast in Korean." (2011) in *Companion to Phonology*.

Youngyeong KIM

Youngyeong Kim is a lecturer who has taught at Sungkyunkwan University. She has a BA, MA and PhD in Korean Philosophy. She has researched the dissemination of Korean folk-Taoism, and how it has influenced Buddhism, Confucianism, and Taoism, especially focusing on its contribution to the formation of national identity by analyzing the case study of the Japanese colonial period in South Korea. In addition, through research on Korean Folk Taoism, she has examined how this ancient tradition has interacted with Western-style materialism in terms of recent historical and cultural events. Her recent book is *Chowondamlo* (椒園談老) (Seoul: Yemoonsewon, 2013).

Kevin N. CAWLEY

Dr. Kevin N. Cawley is the director of the Irish Institute of Korean Studies (IIKS) and acting head of the Department of Asian Studies at University College Cork (UCC), Ireland. He researches and lectures on 'Korea's Religious and Philosophical Traditions', and is currently preparing a book for publication with Routledge (NY) on this subject. Dr. Cawley is also the managing editor of the online peer-reviewed *Irish Journal of Asian Studies* (IJAS). He also set up the Irish Association for Asian Studies (IAAS) in order to promote the growth and development of Asian Studies in Ireland.

Albert L. PARK

Albert L. Park is an associate professor of history at Claremont McKenna College (California, USA). As a historian of modern Korea and East Asia, his current research interest is centered on the relationship between culture and political economy and alternative forms of modernity. He is the author of Building a Heaven on Earth: Religion, Activism and Protest in Japanese Occupied Korea and is the co-editor of Encountering Modernity: Christianity and East Asia. His current research project is on alternative conceptions and practices of democracy under neoliberalism, which is tentatively titled Designing and Building Utopia: Culturally Reconstructing Democracy in Contemporary South Korea thorough Architecture, Design, and Food. Dr. Park is Co-Principal Investigator of EnviroLab Asia—a Henry Luce Foundation-funded initiative at the Claremont Colleges that studies environmental issues in Asia through an interdisciplinary lens. He is the recipient of three Fulbright Fellowships and fellowships from the Korea Foundation and the Center for East Asian Studies at the University of Chicago. A native of Chicago, he received his B.A. with honors from Northwestern University, an M.A. from Columbia University and Ph.D. in History from the University of Chicago.

CHEON Myeong-Kwan

Cheon Myeong-Kwan was born in Yong-in, South Korea, in 1964. Prior to becoming a novelist, he worked as a screenwriter. His literary debut, the short story 'Frank and I', earned the Munhakdongnae New Writer Award (2003). His first novel, 'The Whale' received the Munhakdongnae Award for Best Novel in 2004.

HAN Yujoo

Han Yujoo has written three short story collections and the novel 'The Impossible Fairy Tale', which will be published by Graywolf Press in 2017. She is a translator of Michael Ondaatje and Geoff Dyer, among others, and teaches at the Seoul Institute of the Arts and Korea University's Department of Creative Writing.

It was established in 2009 by the Korean Ministry of Culture, Sports and Tourism to promote and support Korean language learning and teaching programmes overseas as well as in Korea. Currently there are 115 institutes worldwide.

King Sejong Institute London

Since 2011 SOAS Language Centre has hosted London's King Sejong Institute. It supports our intermediate and advanced language courses. As a result of this support the Language Centre is able to offer 30% discount on fees for its intermediate and advanced level Korean language courses.

What the King Sejong Institute does

Research and develop Korean language programmes and their course syllabi. There are 7 levels from beginners to advanced:

- Level 1 & 2: elementary
- Level 3 & 4: intermediate
- Level 5 & 6: advanced
- Level 7: higher advanced

The syllabus for each level is based on the 'International Korean Language Education Standard Model' developed by the National Institute of the Korean Language.

Develop course materials and providing online materials to the learners and teachers of Korean. Currently, Sejong Korean 1 and 2 are published and available for use. Each Sejong Institute is encouraged to use these text books if possible. On-line materials to accompany them can be found at King Sejong web site.

Promote the understanding of Korean Culture through activities and events organised by the Korean Cultural Centre.

Organise annual workshops and events. Teachers and students from all Sejong Institutes are invited to these workshops where they can share their practical experience of teaching and learning with one another and enjoy a wide range of cultural events.

Workshop
Writing North Korean social history
11 September 2016

A successful and engaging workshop on North Korean social history was held on September 11, 2015, bringing together scholars from North America and Europe working on this developing field. The one-day event was divided into three sessions. The first two sessions consisted of presentations of recent research by six presenters, along with comments from two discussants. The third session was a roundtable discussion among all the participants on the practice and challenges of researching and writing North Korean history.

Despite the ever-growing popular fascination with North Korea, general understanding of the country and its history is advancing much more slowly. At times it appears to be a country without a history, where society, from top to bottom, is inscrutable to historical knowledge. The outline of North Korea's political history is fairly well known and numerous books chart the rise of Kim Il Sung and the establishment of North Korea's monolithic politicalideological system. But beyond this our understanding of the country's history is obscured both by the



DPRK state with its near total control of information about North Korea and substantial capacity for historical mythmaking, and by the preconceptions and narrow concerns of media and academia in the English-speaking world. This workshop sought to encourage the further development of this emerging field of historical inquiry by bringing together a number of scholars from around the world working on new social histories of North Korea.

Symposium

Film and History: The Korean Example 5-6 November 2015

Film and History: The Korean Example conference took place at SOAS and KCCUK in London on 5 and 6. November 2015. This interdisciplinary international conference was organized by the Centre of Korean Studies and the Centre for Film Studies, SOAS, University of London (academic organiser, Dr Hyunseon Lee) in cooperation with The London Korean Cultural Centre UK.

This two day conference was attended by over 70 delegates, and scholars from nine countries, researching in literature, history, Korean culture, film and media studies, have examined intensively the changing modes, impacts and functions of screen images dealing with history with the case study of Korean cinema. The discussions have been focused on the representations of history on film and the links between historical research and filmic presentations of history.



The keynote lecture was given by Professor Hong-Joon Kim (Korea National University of Arts, Seoul). His talk, entitled Witnesses Witnessed: Reflections on the Lives and Times of Three Korean Master Filmmakers recounted some key episodes from Professor Kim's' close encounters' with three Korean masters: Shin Sang-ok, Kim Ki-young and Yu Hyun-mok. Celebrating the 10th London Korean Film Festival, Korean film directors Jang Gunjae (A Midsummer's Fantasia), Nam Dong-chul (Busan International Film Festival Programmer) and Kate Taylor (BFI London Film Festival programmer) made a special panel contribution and discussed the relationship between independent film-making and international film festivals

Conference

Joint East Asian Studies (JEAS) Conference 7. 8. 9 September 2016

The Joint East Asian Studies Conference (JEAS) was among the many events the Centre was involved with in 2015/16. It is a triennial conference run by the three academic associations representing East Asian Studies in the UK, namely the British Association for Korean Studies (BAKS), the British Association for Chinese Studies (BACS) and the British Association for Japanese Studies (BAJS). Since its inception more than two decades ago, the conference has been a major venue for the dissemination of research on East Asian studies in various fields and disciplines.

BAKS was proud to invite Professor Charles Armstrong from Columbia University as its keynote speaker. Despite having arrived in London only a few hours before his speech, Prof. Armstrong delivered a thought-provoking on the Korean War. In general, North Korea was a much-discussed issue in several of the forty or so panels that focused on Korea. Other Korea-related themes and issues explored during the three-day event included music, art, cinema, ageing and gender.

At the JEAS Conference, Dr.
Charlotte Horlyck was elected
the new President of BAKS. She takes over from Dr. James Lewis,
Associate Professor of Korean History at Oxford University, who
is stepping down so as to devote more time to his position as
President of AKSE (Association of Korean Studies in Europe).

With more than two hundred academics presenting papers, JEAS 2016 was the best-attended, and arguably the most successful in history. CKS would like to extend its thanks to the Centres and Programmes Office for leading the organisation of the conference. Our thanks also go to BAKS and the institutions that offered funding, including the Embassy of the Republic of Korea, the Korean Cultural Centre as well as the British Korean Society.

Deconstruting Boundaries: is East Asian Art History possible? 10-11 October 2015

This symposium should be identified as, not only the second phase of the previous June 2013 'International Modern Japanese Art History Symposium – New Boundaries in the Study of Modern Japanese Art: Extending Geographical, Temporal and Generic Paradigms' – generously supported by JRC Office, JSPS London and SISJAC (Sainsbury Institute for the Study of Japanese Arts and Culture) - but also as a further development of study with the key theme, 'Deconstructing Boundaries in East Asian Art and Japanese Art History'.

The aim of this symposium was to give insight into the changing boundaries and concepts of 'art' in Japan and East Asia. We especially hoped to illuminate the exchanges and dialogues that took place among the artists of Japan and other East Asian nations.

The birth of East Asian art history could not have occurred without the symbiotic relationships among various groups of artists. Papers have challenged the existing geographic, temporal, and generic paradigms that currently frame the art history of East Asia. What was the relationship between artistic production and political discourse? What role did abiding cultural legacies play in the artistic development of East Asia at large? At this conference, the discussions were expanded to include include scholars from Chinese and Korean art history.

The symposium offered three key themes: Constructing the idea of East Asian Art in Japan; Japanese Academies as a Centre; and War and Body, presented by a total of sixteen speakers including five keynote speakers from Japan.

This symposium was expected not only to enhance the awareness of East Asian

Art studies from the global point of view, but also strongly to promote study and research for young scholars and students in Japan. Therefore, three representative Ph.D. candidates from Japan presented papers along with prominent scholars. Both senior and junior scholars presented their research in order to stimulate the development of further studies in the area. The participants came from various backgrounds, such as Japanese art history, Korean art history, and Chinese art history.

Through the two-day conference in 2015, questions relating to methodology in (re)constructing a broad history of East Asian art had also been addressed in this symposium. A wide range of backgrounds were represented in the audiences, not only people with East Asian and European Art history backgrounds, but also soaciologists and researchers in international relations: furthermore people gathered together from East Asia, the United States, and Europe, and exchanged and shared their ideas during the discussion time and built new scholarly networks during the symposium.

This symposium attracted a wide range of scholars who have been not only interested in Japanese art but also the relationship with East Asian art history, and also the new framework of 'East Asian Art' and the definition of 'Art History.' Moreover, the symposium speakers have shown a completely new way in which to see and analyse Japanese Art History to people that are engaged in Japanese studies in Europe, as well as to stimulate audiences with the newest topics in Japanese art history. The presentations and exchange of information about research topics have given a rare and important opportunity for, in particular, young scholars to create close relationships in the near-future, and to develop intellectual communications beyond countries and their study areas.

After successfully completing this symposium, the anthology by speakers will be published during FY2017.



Korean Peninsula Cinema: Revisiting North and South Korean films from a perspective of Korean Studies

Outline of the project

My hypothesis of this two year project was that the existing Korean cinema research in English speaking countries focuses mostly on South Korean cinema and films produced after the 1990s. There is a lack of serious interest on Korean cinema both as a research and academic subject in the higher educational institutions. This denies that public interest in Korean cinema is growing constantly as shown in European film festivals and distribution of recent films. There are only a few courses on Korean cinema despite the growing interest in this subject. It is true that it is not easy to find appropriate teaching materials due to lack of written works and only few written essays on the films before 1990s and North Korean films.

The initial goal for the first year was to draw up a broad inventory of Korean films and related publications available in Western Europe. For the second year, my projected aim was to use this data to research basic trends in the reception of Korean films in Western Europe, thereby elaborating a new methodology and approach to the topic and contributing to theories of Korean Peninsular Film with publications. Thus far, the project has progressed far more quickly and systematically than initially expected, and a clear outline is being defined.

One way in which research has progressed is through the collection of data with the aim of producing a database of Korean films and relevant publications available in Western Europe. This has been achieved both through online research and through visits to various archives, film institutes, and research centres across the region, namely the Deutsche Kinemathek (Berlin), the EYE Film Institute (Amsterdam), the British Film Institute (London), the Cinémathèque Française, and the Centre Pompidou (both in Paris), and Cineteca Nazionale - Centro Sperimentale di Cinematografia; Settore Scuola Nazionale di Cinema; Biblioteca Luigi Chiarini, and Archivio Audiovisivo del movimento operaio e democratico (both in Roma).

In the second year I am focusing on the reception of the Korean peninsula cinema in Europe. Hereby I am dealing with the term Korean peninsula cinema and, until now, the neglected north Korean cinema. I will also look at themes new to the centre of research. 'The Korean' will need to be defined in terms of how it is understood in both North and South Korean films. The focus on history, the film industry and political and juridical conditions of North and South Korean films draws attention to the transnational and the trancultural aspects of both film cultures. During my research, I have been aided by a research assistant, Andrew Cummings, last year.

Alongside data collection, I have been presenting my research on Peninsular Cinema at International Conferences and already published essays on both North and South Korean films and am now preparing further academic publications.
